FLORISTIC QUALITY ASSESSMENT COMPUTER PROGRAM

Floristic Quality Assessment (FQA) is a method that was devised to evaluate the natural quality of open land using vegetation. This method was first described in the 3rd edition of *Plants of the Chicago Region*, 1979, and later updated in the 4th edition in 1994.

The software is a Windows-based program and includes both the Inventory and Transect assessments. Seven databases are currently available and include – Illinois, Indiana, Iowa, Michigan, Kentucky, the Dakotas, and the Chicago Region. The Chicago Region covers the following 22 counties: Illinois – *Boone, Cook, DeKalb, DuPage, Grundy, Kane, Kankakee, Kendall, Lake, McHenry, Will*; Indiana - *Jasper, Lake, LaPorte, Newton, Porter, St. Joseph, Starke*; Michigan - *Berrien*; and Wisconsin – *Kenosha, Racine, Walworth*. Future database offerings may include southern Ontario, northeastern Ohio, and Missouri.
